

Manleigh Park- Terms and Conditions

Arrivals

We welcome arrivals from 4pm. If you think you will be arriving early please call ahead.

Departures

Please vacate your accommodation by 10am and hand your keys into reception before leaving.

Gas & Electricity

There is no extra charge for Gas & Electricity

Bed Linen

Bed linen is provided at no extra charge.

Car Parking

Chalets & Log Cabins have 1 allocated parking space. There is a car park for Caravan rentals. Should you require an additional parking space, please speak to reception on arrival.

Deposit

A deposit of 20% of the total cost of your holiday is due at the time of booking. The balance is due 6 weeks before the start of your holiday

Dogs.

We welcome dogs at Manleigh. Please tell us at the time of booking if you are bringing a pet. Pets other than dogs can only be accepted with prior permission from us.

Please bring your dogs bedding and feeding bowls. Please do not allow your pets on the furniture or beds. Please do not use the crockery in your accommodation to feed your dog.

Dogs must be supervised at all times and must never be left alone in your accommodation if you are off site.

Dogs must be on a lead at all times within the park boundaries. You may exercise your dog in the field adjacent to the park, however, we cannot guarantee that all the boundaries of the field are secure. Please be aware there may be livestock in neighbouring fields.

Please clean up after your dog in all areas of the park, including the field. Bins are provided.

If you have a pet allergy we endeavour to keep a number of properties Pet Free, but cannot guarantee that a pet has never stayed in the property. We cannot be held responsible for any subsequent health reactions.

Personal Possessions

Whilst at Manleigh you are responsible for all your personal possessions. We are not liable for any damages or the loss of any possessions.

Please ensure you take all your belongings away with you when you leave. If you realise you have left something behind, please contact us as soon as possible.
